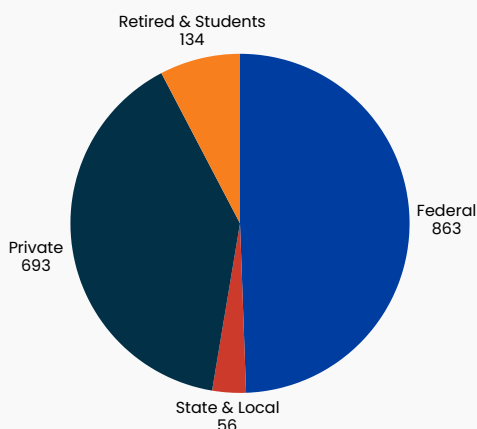
CHAPTER ORGANIZATIONAL STRUCTURE

Membership by Length

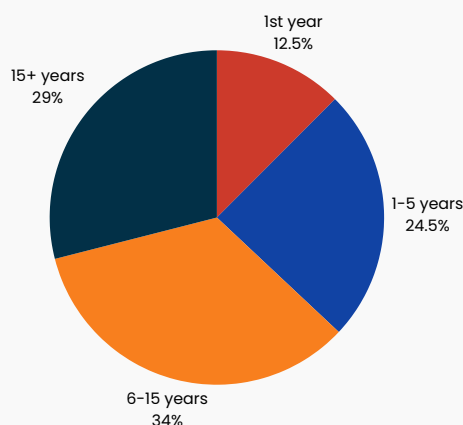

We also joined the St. Jude Walk, raising \$1,301 for research and treatment.

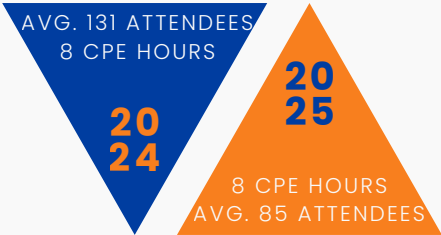
YOUNG PROFESSIONALS

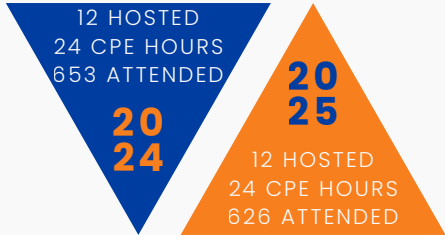
EVENTS BY THE NUMBERS

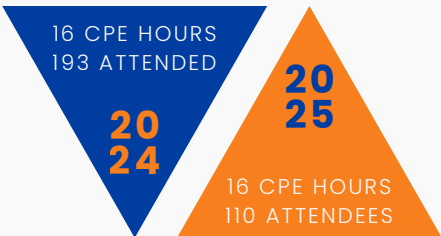

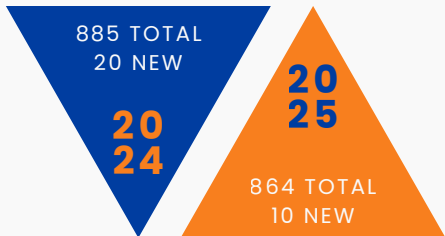

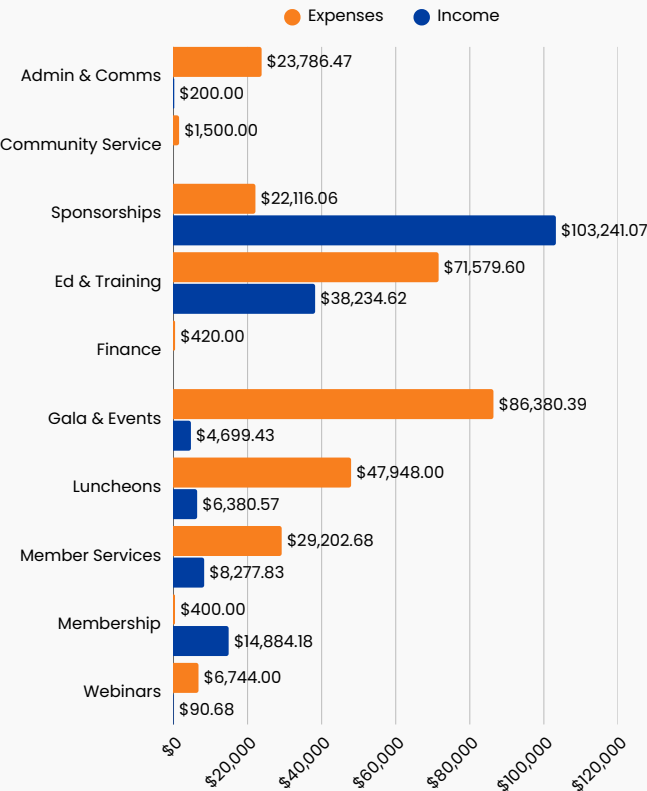
FINANCIALS

In Program Year 2024–2025, we maintained a strong financial position with a positive cash balance of \$270,519 as of June 30, 2025, despite increased costs. Costs rose due to a new spring training venue, expanded hybrid and in-person member events, increased luncheon and sponsor-related expenses, and our continued commitment to providing discounts and subsidizing member event costs to encourage participation and show our appreciation.

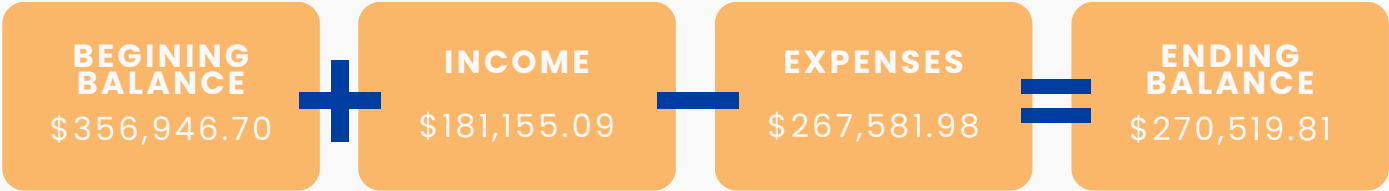
On the income side, corporate sponsorships grew by \$26,000, but membership dues fell by \$3,000 and spring training ticket sales declined by \$21,000, likely due to changes in federal funding policies.

We have not conducted an independent audit, but are currently conducting an internal review through the Strategic Direction Committee, independent of the Finance Committee, to build on recent process improvements and identify further efficiencies. 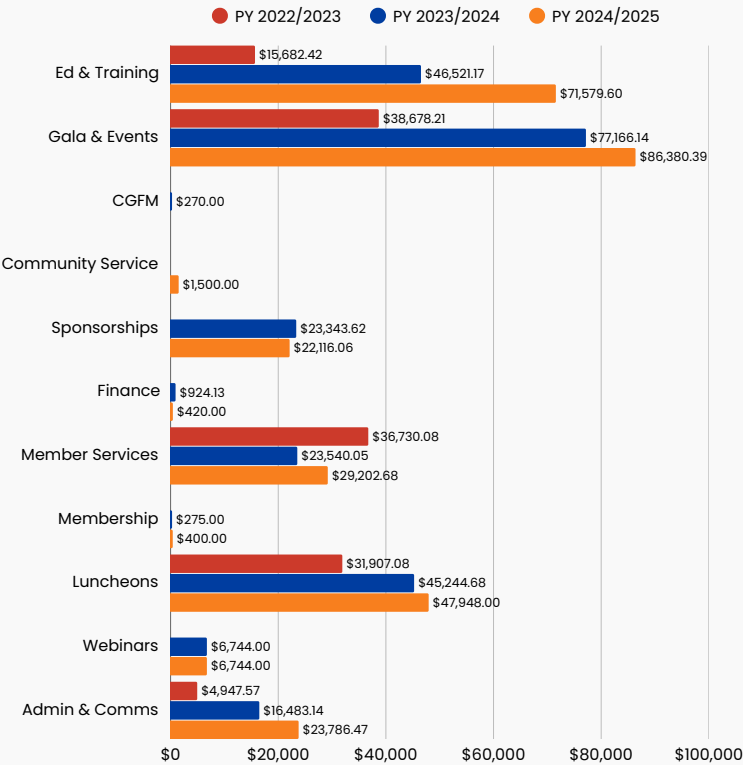
Program Year 2024/2025 Financials



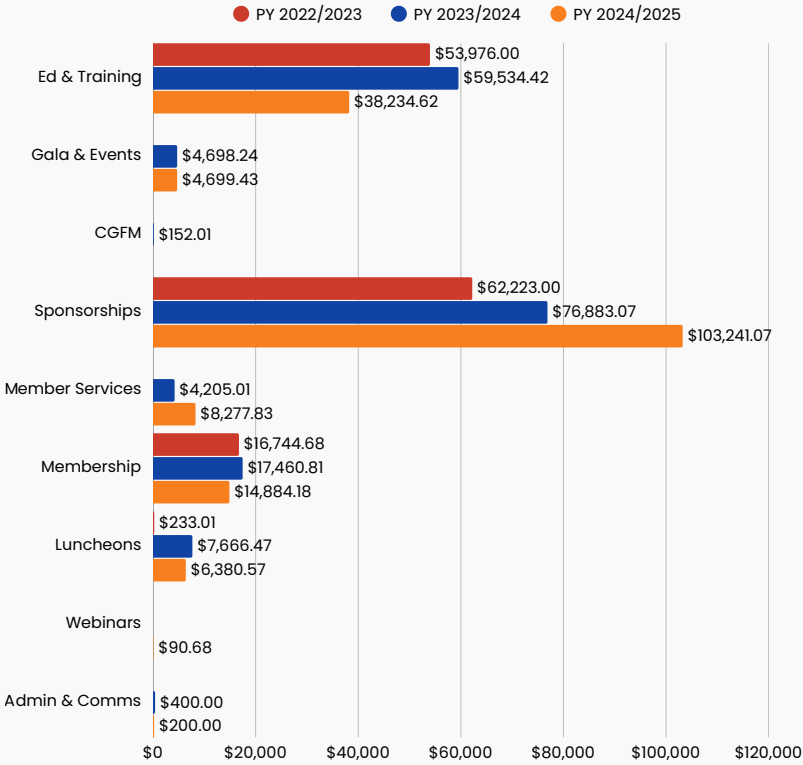
